The forum acts as a conduit to and from the NW SPF sub group, highlighting specific workforce issues and ensuring a clear flow of information to and from local employer organisations.

Welcome and context

Welcome to the key communications from the Lancashire and South Cumbria Social Partnership Forum which is a sub group of the North West SPF and the North of England SPF. The meeting was held at the Education Centre at Chorley and South Ribble Hospital on 2nd February 2018. This was the second meeting of the forum.

Damian Gallagher talked about the programme in Cumbria and Lancashire. Paula Roles clarified the approach being taken in the streamlining policy group which is a means of sharing best practice, ideas and improving engagement. Examples of best practice in Morecambe Bay, North Cumbria and Pennine Lancashire were referenced. As employers, we are all seeking to attract and retain staff and position ourselves as model employers so it is not about making changes that could be detrimental. It was also clarified that any changes to policies have to be made via the local governance structures within organisations.
