4. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint could benefit from children's hospice care.

A North West point prevalence study was undertaken by Lancaster University in February 2023. This study identified 344 children and young people with palliative care needs in Lancashire and South Cumbria. The study provided insight into the demographics of these children and young people

- 8% were babies under one, 93% children over one
- Highest category were children 6-10 years (27%), followed by 1-5 years (26%) and 11-15 years (23%)
- 55% of children and young people were male
- 67% were from a white ethnic background, 16% were from a South Asian background. This highlights an over representation of the South Asian Community where general ethnicity data highlights 8% of the North West population is South Asian. Therefore there is more than expected based on population demographics. Conversely less children from the South Asian community were actively in treatment during in the point prevalence study (one week in February)
- The main condition for palliative and end of life care needs was neurological (37%), followed by respiratory (13%), congenital (13%), circulatory (10%), oncology (8%), metabolic (5%), gastrointestinal (4%), genitourinary (2%), Haematology (1%)
- The services supporting children in order of highest access was community teams (37%), hospice (21%), general hospitals (20%) and children's specialist hospitals (19%)
- The prognosis of those children were highlighted as
 - 2% in the last days/weeks of life
 - 7% increasing instability or progressive deterioration (Months)
 - 22% increasing instability or progressive deterioration (Years)
 - 28% death before adulthood is not unexpected
 - 33% diagnosis of a potential life-limiting condition, survival into adulthood expected

The information from the prevalence study provides the system with additional intelligence to help inform and plan services to meet need.

Please note that not all of these children will require or choose hospice care.

5.
