- IDAP integrated at neighbourhood level


2026/27- Prepare the ground

- Delivery of the Dental Access & OHI Plan Year 2
- Making the best use of existing resources available to reduce inequalities, address variation and maximise access opportunities for priority groups – eg expanding & integrating ‘Integrated Dental Access Practices’ (IDAP)/Paeds pathway
- Development of left shift plan – eg MOS, enhanced discharge pathways and shared care models
- Delivery quality improvement scheme Year 1
- Develop a plan to address recommendations from OHNA for special care adults and paeds
- Delivery of national contract reform including urgent/unscheduled care
- Call Handling Procurement
- Referral Management Service Procurement

2028/29 – Going further with pathway development

- Dry Eye / Ocular Surface Disease care pathway **
- Integrated Diagnostic tests in community **
- Maculopathy referral refinement and stable disease monitoring **
- ECSP A – embed into culture and way of working



2027/28 – Progress selected pathways for Integrated working

- Integrated Children's Services – post-vision screening pathway **
- Community glaucoma monitoring **
- Naevus monitoring (expansion of service in central patch) **
- Specialist Contact Lens Service **
- Hydroxychloroquine retinopathy monitoring **
- ECSP – embed in pathways, contracts, service specifications

2026/27 – New foundations

- **Workforce:** invest in development of required competencies (IP & Glaucoma): academic, clinical placements, and managed clinical networks *
- Implement national specification for **BP & pulse** measurement. *
- Implement recommendations to address **equality of access to GOS**.
- Support Planned Care in **referral management**, clinical triage, and delivery of patient choice. **
- Eye care support pathway (ECSP) – communicate principles in system
- Supporting the development of a primary care provider collaborative

2025/26 – Preparing the ground
