Launch of the NHS Long Term Plan

The ten-year plan for the NHS has been launched. The plan, developed by NHS England and NHS Improvement, will guide the investment of the extra £20.5bn being made available to the NHS, which was announced last June.

The NHS Long Term Plan will grow and better support the workforce and invest in new technologies to bring the health and social care services into the digital age. There will be a new focus on prevention, personal responsibility and promoting good health, and more rapid diagnostics and new treatments will improve care

A letter from the Permanent Secretary for the Department of Health and Social Care has been sent to adult social care providers and commissioners providing further detail on Government's preparations for a March 'no deal' scenario for adult social care. Accompanying the letter is EU Exit Operational Readiness Guidance

which will support the health and care system in England to be prepared for a 'no deal' exit. Adult social care providers are encouraged to use this guidance as a prompt to test contingency plans.

Data Security and Protection Toolkit (DSPT)

The Data Security and Protection Toolkit (DSPT) is an online self-assessment tool for data security which supports organisations in demonstrating:

- 1. General Data Protection Regulation (GDPR) compliance.
- 2. Compliance with the expected data security standards for health and social care for holding, processing or sharing personal data.
- 3. Readiness to access secure health and care digital methods of information sharing such as NHSmail and Summary Care Records (a summary of GP information about an individual) and local information sharing solutions. *NHS mail allows summary care information to be shared between health & social care.*
- 4. Good data security to the CQC as part of the Key lines of Enquiry (KLOEs).

Flu vaccinations

Flu vaccinations are available for people working in care homes and care in the home. Health and social care staff need to be aged 18 and over, employed by a registered residential care/nursing home or registered domiciliary care provider who are directly involved in the care of vulnerable people at increased risk from exposure to influenza, meaning those people in a clinical risk group or aged 65 years and over.

Capacity Tracker

All bed vacancies for care homes are now sourced for patients/clients through the Capacity Tracker. Providers need to activate the tracker and to update it on a regular basis, even if there are no changes as discharge teams will focus on the providers where there are vacancies.
