- Improving engagement of the workforce with the programme

To look at ways to improve engagement with the wider workforce, meetings have taken place recently at Trusts with managers from the different specialist teams working with Head and Neck services e.g. nursing, radiology, theatres, therapies. The purpose of the meetings was to understand the best methods to reach this wider workforce who may not access the Key Messages or be able to attend the engagement meetings. The main findings were:

- The meetings enabled the distribution list for the Key Messages document to be strengthened

- AHP representation has been identified for both the scoring panel and at Head and Neck Steering Group meetings

- It is important to ensure there is clear information for the contacts within Trusts to enable people to ask questions and share feedback

- Outcomes from scoring the shortlisted options for delivering Head and Neck services Between 23/09/19 and 06/10/19 the members of the Head and Neck services scoring panel carried out the exercise to score the options for delivering Head and Neck services against the seven agreed evaluation criteria. The purpose of this exercise was to arrive at the preferred clinical model. The location of the hub(s) and spoke sites will be considered later in the process. The outcomes of the scoring exercise are as follows:

Option 2a was the highest scoring option for both head and neck cancer and OMFS services
Option 2bi scored second for head and neck cancer services but third for OMFS services -

the weaker area being the score for the Workforce Impact theme which was 33.89%.

• Option 2bii scored second for OMFS and whilst the weaker area was again the Workforce Impact theme it scored better than 2bi at 49.72%.

Options 2a, 2bi, 2bii look like this:

The Steering Group agreed to move options 2a and 2bii onto the next stage and these options will now be worked up in more detail relating to workforce, capacity and costs to provide a better understanding around what each option involves.
