Diagnostic Radiology - Image Storage, Sharing and Reporting

The vision for the future for L&SC diagnostic services is that images and the associated reports, can be stored and shared via digital integration of systems so that they can be easily viewed by clinical teams within any L&SC trust, irrespective of where the image/report was generated. This is possible in some trusts already but requires manual processes to make it happen and there are frustrations with different systems/logins across the trusts.

Work is underway to explore the options for achieving image/report sharing across L&SC and a phase of testing will take place between trusts during 2020 to understand any issues and resolve these before rolling out any long term solution. Further updates will be provided as planning for the testing phase progresses.

Interventional Radiology Regional Pathways

The Interventional Radiology Group consists of Lead Interventional Radiologists and Business Managers from the four acute trust providers in Lancashire & South Cumbria (L&SC) supported by the L&SC Clinical Lead and Diagnostics Programme Team. Having agreed and implemented the L&SC wide pathways for site specialties that require emergency IR intervention out of hours, the second set of pathways for in hours emergencies in the following specialties: obstetrics (postpartum haemorrhage), trauma, urology (insertion of nephrostomy tube) and vascular have now been agreed. These pathways were drafted by the IR Group and then consultation was undertaken with the site specialty leads in each of the 4 trusts. The pathways were agreed by Trust MDs in June 2019 and have now been circulated to all trusts for full implementation. All agreed IR pathways can be found on the <u>ICS website</u>.

Interventional Radiology Workforce

Work is being undertaken to understand the IR workforce expertise that is in L&SC, where the consultant workforce is based and how we ensure all patients in L&SC have access to appropriate interventional procedures. Basic scoping of the IR workforce has been undertaken and the results will be available shortly.

Endoscopy

Further to the completed L&SC endoscopy review (March 2018), the L&SC Endoscopy Working Group meets regularly (2 monthly). The group are supporting a regional capacity and demand exercise which will identify current capacity issues and take account of the increased demand forecasted (through the bowel screening programme expansion and the population profile of older patients).

The need to support and develop a non-medical endoscopist workforce is a high priority and key links are being made with Health Education England and the Cancer Alliance to support trusts to this end. A L&SC non medical endoscopist training specification has been agreed and a gap analysis against the recommendations is being undertaken. The group are also keen to ensure a robust "train the trainer" system is in place.

EUS in L&SC

Two trusts (BTH and UHMB) are currently unable to undertake EUS due to a lack of specific consultant expertise availability locally. A workshop was held on 10th September with senior clinical representation from all 4 trusts to agree a regional approach to EUS provision that will meet the needs of the L&SC population. The outcomes of the workshop will be available at the beginning of October with a proposed plan for implementation.
