Purpose of the paper

This report provides an update to the Lancashire and South Cumbria Integrated Care Board (ICB) on the continued development of the Integrated Care Strategy. It sets out the key updates that have been made to the strategy during February / March 2023, along with next steps to finalise the strategy.

Executive summary

The Health and Care Act (2022) requires the Lancashire and South Cumbria Integrated Care Partnership (ICP), of which the ICB is a founding member, to develop an Integrated Care Strategy. The ICB must have regard to, and ensure alignment with, this Integrated Care Strategy as it develops its own strategic and operational plans.

During February and March 2023, several routes have been used to seek feedback on the content and layout of the strategy from our stakeholders, which is reflected in the attached document. This is now undergoing a further period of resident engagement to determine whether the strategy document and the priorities it sets out can be easily understood and are meaningful to residents.

Following this, further updates to the language and layout of the strategy will be made.

The Lancashire and South Cumbria Integrated Care Strategy will be approved by the ICP in April 2023.

Integrated Care Strategy

1. Introduction

- 1.1 This report provides an update to the Lancashire and South Cumbria Integrated Care Board (ICB) on the continued development of the Integrated Care Strategy, following previous presentation of the draft strategy to the Board at its meeting on 1 February 2023.
- 1.2 The report sets out the key updates that have been made to the strategy during February and March 2023, along with next steps to finalise the strategy.
- 1.3 The Health and Care Act (2022) requires the Lancashire and South Cumbria Integrated Care Partnership (ICP), of which the ICB is a founding member, to develop an Integrated Care Strategy. The ICB must have regard to, and ensure alignment with, this Integrated Care Strategy as it develops its own strategic and operational plans.

2. Key updates to the Integrated Care Strategy during February/March 2023

- 2.1 A draft of the Integrated Care Strategy was presented to the ICB Board meeting on 1 February 2023. During February / March, several routes have been used to seek feedback on the content and layout of the strategy from our stakeholders, including:
 - The ICB Board meeting on 1 February 2023
 - The Strategy Development Group (with membership including our life course priority executive leads) and its Readers' Panel sub-group
 - Health and Wellbeing Boards
 - Our four place-based partnerships
 - The Provider Collaborative
 - The voluntary, community, faith and social enterprise sector
- 2.2 Based on this feedback, several changes have been made to the document:
 - Overarching updates to language and increased use of infographics to improve readability for our residents
 - Inclusion of quotes from our residents on living and working in Lancashire and South Cumbria
 - Summary of the geography and demographics of our places
 - Updates to the vision and inclusion of proposed measures of success
 - Refreshed descriptions of our life course priorities and inclusion of case studies
 - Addition of a section on key underpinning themes, including our workforce, supporting unpaid carers, digital resources and use of information, our buildings, and our commitment to sustainability

- 2.3 The updated version of the strategy is provided as Appendix A.

3. Next steps to finalise the strategy

- 3.1 During March 2023, there is a further period of resident engagement on this version of the strategy. The purpose of this is to determine whether the strategy document and the priorities it sets out can be easily understood and are meaningful to residents.
- 3.2 As with previous resident engagement, this is being undertaken through a combination of an online survey, existing resident groups, and 'pop up' stalls across the Lancashire and South Cumbria footprint. To maximise reach and diversity, activities are being supported through Healthwatch Together and each Healthwatch in our four places; the voluntary, community, faith and social enterprise sector; district councils; and the ICB communications and engagement team.
- 3.3 Feedback received from our residents will be reviewed during w/c 27 March 2023. Further updates to the language and layout of the strategy will be made during that week, and final design work completed.
- 3.4 The Lancashire and South Cumbria Integrated Care Strategy will be approved by the ICP in April 2023. Following this, it will be presented to the ICB for formal adoption and agreement by the ICB.

4. Conclusion

4.1 The Lancashire and South Cumbria Integrated Care Strategy has been created with significant engagement with stakeholders (the organisations and sectors who make up our integrated care system and ICP) and residents. This engagement has focused on the content of the strategy, particularly the proposed priorities, and the understandability / readability of the strategy. A final version will be approved by the ICP in April 2023.
