As I am aware some external organisations diagnose but do not treat ADHD and so it is important to differentiate between providers. And for these organisations to be separated into those that provide services for children and adults.

This request is not seeking any patient numbers referred to the service, nor is it looking for contract values, merely the names the organisation have active ADHD contracts and the therefore the start and projected end date of these contracts.

Blackpool services are commissioned to Blackpool Teaching Hospitals NHS Foundation Trust (BTH) on a block contract basis, renewed annually.

The contract began with Lancashire and South Cumbria ICB when transferring over from CCGs on 1st August 2022.
