Q1	Your Question:
	Any documentation and information held by NHS Lancashire and South Cumbria ICB, including documentation showing decisions made during the procurement process (reference C173751), including any and all prior communications with economic operators, namely Primary Eyecare Company Ltd within the preceding 12 months, any internal deliberations and decision making approval processes, documents dealing with the preparation of the tender documents and any dialogue or negotiation with potential or prospective bidders.
	I request this information within the last 12-month timeframe only.
	Our Response:
	NHS Lancashire and South Cumbria ICB do hold the information requested however; we are not obliged to provide information relating to commercial interests. In this case, we believe that the information would, or would be likely to, prejudice the commercial interests of the procurement process which is currently being undertaken (section 43(2) of the Act).
	In line with the terms of this exemption in the Freedom of Information Act, we have also considered whether it would be in the public interest for us to provide you with the information, despite the exemption being applicable. In this case, we have concluded that the public interest favours withholding the information whilst the procurement of this service is carried out.

	information to you, we took into account the following factors:
	Public interest considerations favouring disclosure
	 It would provide reassurance to the public by being open and transparent. The general proposition of maximising openness and accountability that the ICB aspires to. The benefits of ensuring transparent and accountable governance by disclosing how ICB receives and spends public money.
	Public interest considerations favouring withholding the information
	 Releasing information would undermine the current procurement process which is still on-going.
	 Releasing the requested information could prejudice the current negotiation capabilities and reduce confidence third parties have with us in order to
	facilitate the decision-making process.The procurement is still currently on-going and to release the information at
	this stage would give competitors an unfair advantage.
	Having taken into account the arguments for and against disclosure, Lancashire and South Cumbria ICB decided that the public interest in this case is best served by maintaining the exemption and by not disclosing the information requested, at this stage. In this case there is an overriding public interest in ensuring that companies are able to compete fairly and ensuring there is competition for public sector contracts.
	We reached the view that, on balance, the public interest is better served by withholding this information under Section 43 (2) of the Act at this time.
Q2	Your Question:
	Any and all patient stakeholder involvement market engagement leading to the decision to procurement within the preceding 12 months.
	Our Response:
	Patient engagement took place in October 2020 as the Tier 1 Ophthalmology procurement was due to commence in Jan 2021. (Engagement had to be undertaken remotely due to covid restrictions which resulted in fewer interactions). Due to lack of capacity within the team, the procurement was paused. The patient engagement report, was positive with regards to standardisation of clinical pathways across LSC and access to optical practices for first line treatment, and equitability of service delivery in each locality. Please refer to the attached report.
