Executive summary

Use of the Integrated Board Seal

The Integrated Care Board (ICB) has a seal for executing documents. The ICB Chair, Chief Executive and Chief Finance Officer are authorised to authenticate use of the Seal. The ICB is required to keep a register of every sealing and to report use of the Seal to the Board at least bi-annually.

Approval of a Special Payment

A special payment is an item that is outside the normal range of departmental activity and is not considered when monies are voted for by Parliament. As such, these transactions are subject to greater control than other payments and are mandatory disclosures within the ICB's Annual Report and Accounts. The ICB has delegated authority to approve special payments up to the value of £95,000. All special payments up to that value must be approved by the Board, in accordance with the ICB's Scheme of Reservation and Delegation.

Use of the Integrated Care Board Seal and Approval of a Special Payment

1. Lancashire and South Cumbria Integrated Board Seal

- 1.1 The Integrated Care Board (ICB) has a Seal for executing documents. The ICB Chair, Chief Executive and Chief Finance Officer are authorised to authenticate use of the Seal.
- 1.2 The ICB is required to keep a register of every sealing and to report use of the Seal to the Board at least bi-annually.

3. Approval of a Special Payment

- 3.1 A claim of £1,149 for reimbursement has been received from an external contractor in respect of replacement of a damaged laptop. The damage occurred at the ICB's County Hall offices and was accidently caused by the movement of a member of ICB staff when leaving the meeting room. Other ICB staff members were witness to the event.
- 3.2 NHS England guidance for Losses and Special Payments identifies that the ICB can approve special payments (excluding those in relation to special severance or retention) up to the value of £95k. This is reflected in the ICB's Standing Financial Instructions, within the Scheme of Reservation and Delegation that states that all special payments up to the value of £95k must be approved by the Board.
