Executive summary

Ratification of Chair's Action: Specialised Commissioning Delegation Agreement

1. Purpose

1.1 This report details Chair's Action taken on behalf of the board in relation to the North West Specialised Commissioning Delegation Agreement between NHS England and Lancashire and South Cumbria Integrated Care Board (ICB), and the Terms of Reference for the North West Specialised Services Joint Committee.

2. Chair's Action

- 2.1 There may occasionally be circumstances where decisions that would normally be made by the Board need to be taken between scheduled meetings, and it is not practicable to call a meeting of the Board.
- 2.2 In these circumstances and in accordance with section 4.9 of the ICB's Standing Orders, the powers which are reserved or delegated to the board may for an urgent decision be exercised by the Chair and Chief Executive (or relevant lead director in the case of committees) subject to every effort having made to consult with as many members as possible in the given circumstances.
- 2.3 The exercise of such powers shall be reported to the next formal meeting of the board for formal ratification and the Audit Committee for oversight.

3. Action Taken

- 3.1 As the ICB Board meeting held in public will be taking place 10 days after as you will be aware, the delegation, there is a requirement for a Chair's action to be taken to sign the delegation document before 1 April 2024 and agree the delegated responsibilities and liabilities transfer on that day.
- 3.2 On 28 March 2024, the Acting Chair, and the Acting Deputy Chief Executive, supported by the Chief Operating Officer and Company Secretary, approved the signing and submission of the North West Specialised Commissioning Delegation Agreement between NHS England and Lancashire and South Cumbria Integrated Care Board (ICB), and the Terms of Reference for the North West Specialised Services Joint Committee. The Joint Committee is a formal committee of NHS Lancashire and South Cumbria ICB, NHS Cheshire and Mersey ICB, and NHS Greater Manchester ICB.
- 3.3 The Chair's Action was taken to ensure that the ICB was ready to receive formal delegation of single-ICB and Multi-ICB Specialised Commissioning Services from 1 April 2024, and that the Joint Committee with NHS Cheshire and Mersey ICB and greater Manchester ICB could be formally established with

effect from 1 April 2024 in order to undertake decision-making for Multi-ICB level services.
