Key Decisions and Actions	<p><b>1 December 2020</b></p> <p><b>ICP Covid Performance Dashboard – Proposed Metrics</b> The Board discussed and agreed the Covid metrics proposed at ICP Senior Leadership Team, with a suggestion to add Covid rates.</p> <p><b>Chorley ED Re-opening</b> The Board was pleased to note that the department has continued to be open safely. It was highlighted that there had been a rise in attendances at ED and a reduction in attendances at the Urgent Care Centre. The Trust was looking into this to establish the appropriateness of attendances at both departments. The Board particularly noted the efficiency of the work undertaken to re-open the unit safely and recognised that a lot of work had been done in a short amount of time.</p> <p><b>Progress of Urgent Care Winter Plan</b> The Board was pleased to note the update on progress of the winter schemes, however, was concerned regarding issues around community therapy workforce and the impacts and risks of this on some of the schemes. The Board welcomed the increase in home first slots and the focus on increasing discharges particularly at the weekend. Additionally the Board was pleased to note the Covid Virtual Ward had been working well and treating patients from both a step up and step down perspective.</p> <p><b>Discharge and Flow Task and Finish Group</b> The Board welcomed the establishment of this group which would focus on implementation of the CATCH review recommendations and actions in the system flow action plan around improving discharge.</p> <p><b>Mental Health Update</b> The Board noted the increase in activity in relation to referrals and the assessment centres which were reducing ED attendances. The Board was pleased note the additional resource for the mental health liaison team and that the frequent attenders team were now fully staffed and the positive impact this would have on reducing ED attendances</p>

	<p><b>Community Services Update</b></p> <p>The Board noted the impact of Covid on LSCFT workforce particularly AHPs and District Nurses. The increase in home first slots and the creation of a sit rep proforma was welcomed. LSCFT has been identified as the ICS lead for long Covid and a meeting was being held soon with the ICS to discuss the detail of what was required in terms of an implementation plan and this would be shared. The importance of considering the physical health aspects of long Covid was highlighted and this was acknowledged.</p> <p><b>Points on EU Exit</b></p> <p>The Board noted the request from the ICS for each locality to have robust plans in place to deal with any impacts from the EU Exit and it was suggested that the exit leads across the patch should meet as partners to discuss their arrangements and any potential issues. The Trust had received a checklist and would share this with partners.</p> <p>The Chair thanked the Board and their teams for the continuing work around improving discharge and managing urgent care.</p>
